



Executive Order No. 2
Series of 2024

An order addressing the community service requirement concerning ASWSU and Student Led Conferences.

Whereas, the Multicultural community has begun operations under the point accumulation system as outlined in Executive Order No. 1 (2024);

Whereas, the MGC Bylaws have implemented the policy that “ASWSU Multicultural Conferences and Student-Led Conferences may not account for more than (1/2) of the total hours completed toward the individual member requirement, and Members are welcome to complete hours via these conferences that will count toward Chapter Total, however only half of the required total will count toward “minimum requirements”;

Whereas, the Multicultural Greek Council recognizes the time commitment and service that is performed by Directors, Co-Chairs, and Team Leaders of the various conferences the community serves in;

Section I: Declaration of Policy

- The creation of the following subsection to Appendix G, Article II.3.ii:
 - “Directors, Co-Chairs, and Team Leaders of ASWSU Multicultural Conferences and Student-Led Conferences shall be exempt from the total hour requirement outlined in Appendix G, Article II.A.3.”

Section II: Implementation of Policy

- This policy is effective February 8th.

Section III: Expiration of Policy

- This Executive Order shall be congruent with the expiration or adoption of Executive Order No. 1 (2024).
- Unless reinstated by executive order or adopted to the MGC Bylaws by the vote of the MGC Delegates, this order will expire on June 16th, 2024 in congruence with Executive Order No. 1 (2024).

Section IV: Explanation of Policy

- When taking into consideration the amount of time and effort that Directors, Co-Chairs, and Team Leaders put into the execution of the ASWSU Multicultural Conferences and Student-Led Conferences, the Executive Council believes that they should be exempt from the policy recently

created by Executive Order No. 1 (2024). The Council wants to reinstate its belief that there is a desperate need for community service from all our members in the community, and hope that the execution of Appendix G Article II.3. will allow the opportunity for members of the MGC community to create a impact through both the use of conferences, and in the Pullman-region community as a whole.

Appendix G Community Service Bylaws

ARTICLE I Purpose

The Greek Councils and the Center for Fraternity and Sorority Life at Washington State University believe that community service for undergraduate fraternity and sorority members enhances their college experience outside of the classroom. On top of pre-approved community service opportunities organized by the chapter and/or individual members, the Council's, CFSL, and Center of Civic Engagement provide service opportunities that benefit the surrounding areas of the University and provides both fraternity men and sorority women the opportunity to be active local and global citizens.

ARTICLE II Requirements

- A. Chapters that meet one of the following requirements will have satisfied the community service requirements and will not be subject to penalties outlined in Article IV, Appendix H.
 1. Eighty percent (80%) of each chapter of the Multicultural Greek Council are required to complete twelve (12) hours of community service each semester, or the
 - i. In order for service opportunities to be recorded by the CCE and hours to count towards a chapter's final report, the community partner or event must be pre-approved with the CCE.
 - ii. Any service completed between June 16th, and December 15th shall count for the Fall Semester
 - iii. Any Service Completed between December 16th and June 15th shall count for the Spring Semester
 2. Average hours per member of the chapter meets or exceeds twelve (12) hours per member.
 3. ASWSU Multicultural Conferences and Student-Led Conferences may not account for more than (1/2) of the total hours completed toward the individual member requirement
 - i. Members are welcome to complete additional hours via these conferences that will count toward Chapter Total, however only half of the required total will count toward "minimum requirements".
 - ii. **Directors, Co-Chairs, and Team Leaders of ASWSU Multicultural Conferences and Student-Led Conferences shall be exempt from the total hour requirement outlined in Appendix G, Article II.A.3.**
